SUBJECT: NOTICE OF SUSPENDED FUNDS UNTIL SUBMISSION OF THE 2015-16
IDEA 618 Data

KSDE records indicate that the 2015-2016 IDEA 618 Data from your organization has not been received. The data was due 30 days from the start of the school year.

On September 15, 2015 notification was sent alerting you that the 2015-2016 IDEA 618 Data has not received by KSDE and the 30 day timeline has passed. Your organization was given an additional 2 weeks (10 business days) to comply with the reporting requirements. Because the 2015-2016 IDEA 618 Data was not received by KSDE within this 2 week timeframe, KSDE has suspended your organization's 2015-2016 federal fund payments.

This letter stands as notification that KSDE will begin and continue the suspension of your district's 2015-2016 IDEA VI-B 3-21 (CFDA#84.027) and IDEA VI-B 3-5 (CFDA#84.173) fund payments per Title 20 §1232b of the United States Code, Title I (CFDA #84.010A), Title IIA (CFDA #84.367A), Title III (CFDA #84.365A), and Migrant (CFDA # 84.011A) fund payments per Title 20 §1232b of the United States Code until the 2015-2016 IDEA 618 Data is received by KSDE.

KSDE will release your district's 2015-2016 IDEA VI-B 3-21 (CFDA#84.027) and IDEA VI-B 3-5 (CFDA#84.173), Title I (CFDA #84.010A), Title IIA (CFDA#84.367A), Title III (CFDA #84.365A), and Migrant (CFDA # 84.011A) funds when the 2015 - 2016 618 data is received.
