Special Education Directors:

The SFY13 IDEA VI-B allocation chart follows this letter.

Please be advised there could be revisions to these allocations throughout the fiscal year due to ongoing conversations at the federal level. The changes in allocations are a result of enrollment fluctuations or the shifting of service responsibilities between LEAs as allocations are largely determined by each LEA's percentage of total enrollment and percentage of total children living in poverty. To better facilitate a more uniform award process this fiscal year, the SES team will send award letters only after LEAs submit and are approved for the SFY13 IDEA VI-B allocations rather than distributing allocation packets at the July Leadership Conference. This change will only affect when directors will receive the award letter and will not delay the timing of the draw down process for IDEA IV-B funds. Further guidance on accessing the SFY13 LEA Application Part I along with the application's dates of availability will be sent to directors via email and discussed during future director calls.
