Approved Screeners

Preschool and K-12 students





Approved Screeners

- Preschool Students
 - Pre-IPT or Pre-LAS
 - Not available through KSDE
 - Many programs not only screen to determine eligibility of services, but at the end of the school year to monitor progress.
 - If the screener is administered to a **preschool** student in the spring, the student would NOT need to complete the KELPA screener upon entering kindergarten to remain eligible for services.

- K-12 Students
 - KELPA Screener-only approved K-12 screener in Kansas
 - ksassessments.org
 - KELPA Screener Manual
 - Foreign exchange students-Immigrant by state and federal definition.
 - If student wants to receive services, administer KELPA screener.



Screener Timeline & Next Steps



- If a student is enrolled on the first day of school, the screener must be administered during the first 30 days.
- If a student is enrolled after the first day of school, the screener must be administered within two weeks.
- Complete parent notification if a student is not proficient.
- Complete Individual Learning Plan (ILP).
- Complete the steps throughout the school year as students enroll.

KELPA Pre-Screener Survey

Preschool and K-12 students





When do I use the pre-screener?



- This only applies to students who have recently arrived in the United States for the first time.
- PK-12 students.
- "Submit for Screener" indicates the student should be further evaluated with the Screener. "Bypass Screener" indicates the student would not pass the Screener and qualifies for ESOL.

WIDA Alternate ACCESS English Language Proficiency (ELP) Assessment

New beginning 2023-2024





WIDA Alternate ACCESS ELP for Students with a Most Significant Cognitive Disability



Student has a home language survey indicating language other than English and DLM eligible



Will take place January 29-March 8, 2024 for students in Kdg-12th grade



Paper format, not computer based



Students must have a most significant cognitive disability, most significant deficits in adaptive behavior, and are an English Language learner




Use the same criteria as DLM and the alt early literacy screener to identify which students need the Alt ACCESS



Tests students' English Proficiency in the four domains: listening, reading, speaking, and writing

KS WIDA Alternate ACCESS Participation Decision Tree







When is the test window?

- The Alternate Access assessment window is the same as the KELPA window
 - January 29th March 8th
- •For English Learners with a most significant cognitive disability

Is training required for test administration?

- Yes!
- •Test administration training is required every year.
- •There are 4 modules to complete and one quiz that must be passed.
- Approximately one hour to complete.



When will scores be available?

- Scores won't be available until early
 October due to standards setting.
- •Once standards are set, scores will be available in April each year.

KELPA Screener Kindergarten Alignment Study

- Call for districts to assist researchers in ensuring that cutpoints for kindergarten students are accurate.
 - We need districts to administer the KELPA screener this fall to both English Learner and non-English Learner kindergarteners.
 - Participation is voluntary. Deadline to participate is October 13th.
 - Register native English kindergarteners for the screener using the same registration process and add ENG at the end of the local student identifier of native English Kindergarteners.


