## State Foundation Aid and Supplemental General State Aid (LOB)



Listed below are the *proposed distribution dates* and percent of entitlement for state foundation aid and supplemental general state aid (LOB) under the Kansas School Equity and Enhancement Act.

#### Distribution Date      State Foundation Aid payment amount

- July 13, 2023.....Increase July 2022 state foundation aid by 5.00 %.
- August 1, 2023.....Increase August 2022 state foundation aid by 5.00 %.
- September 1, 2023.....Increase September 2022 state foundation aid by 5.00%
- October 2, 2023 .....Increase October 2022 state foundation aid by 5.00%
- November 1, 2023.....Approximately 8.30 % of the current year's budgeted state foundation aid entitlement.
- December 1, 2023 .....Approximately 8.30 % of the current year's budgeted state foundation aid entitlement.
- January 2, 2024.....Approximately 8.10 % of the current year's budgeted state foundation aid entitlement.
- February 1, 2024.....22.00 % of the remaining amount of current year state foundation aid entitlement.
- March 1, 2024.....19.50 % of the remaining amount of current year state foundation aid entitlement.
- April 1, 2024.....24.50 % of the remaining amount of current year state foundation aid entitlement.
- May 1, 2024.....26.00 % of the remaining amount of current year state foundation aid entitlement.
- June 14, 2024.....46.50 % of the remaining amount of current year state foundation aid entitlement.
- June 21, 2024.....Remaining amount of current year's state foundation aid entitlement.

### Estimated

#### Distribution Date      Supplemental General State Aid (LOB) payment amount

- October 2, 2023.....42.00 % of the following: current year's state aid rate times prior year's legal LOB budget.
- February 1, 2024.....40.00 % of the current year's supplemental general state aid entitlement.
- June 21, 2024.....Remaining amount of current year's supplemental general state aid entitlement.
